I would like to use this letter as an opportunity to update you on the latest developments regarding the Department for Education's response to the coronavirus (COVID-19) outbreak. Please see below an overview of activity over the last week.

On 23 April, DHSC announced the expansion of the Government's testing scheme to all essential workers. If they or anyone in their household has symptoms, they are now eligible for a test to confirm whether they have COVID-19. This includes anyone involved in education, childcare or social work, including both public and voluntary sector workers, as well as foster carers. DHSC has launched a new digital booking service so that employers and eligible essential workers can now book test slots directly. To support early years providers that remain open to vulnerable children and children of critical workers during the coronavirus (COVID-19) outbreak, we have temporarily disapplied and modified elements of the Early Years Foundation Stage (EYFS) statutory framework. This will allow providers greater flexibility to respond to changes in workforce availability and potential high fluctuations in demand, while providing care that is high quality and safe. We have also announced that local authorities will, in exceptional cases, be able to redistribute their free childcare entitlement funding differently to ensure sufficient childcare places are available for the children of critical workers and for vulnerable children, where their usual arrangements are no longer possible as a result of COVID-19. We understand the pressure that schools, colleges, and other educational and care settings are under at this time, and therefore, to help reduce burdens on them, we have cancelled or paused all but the most essential data collections until the end of June 2020. To support remote education, we have published guidance to help schools and teachers to understand how to follow safeguarding procedures when teaching remotely during the coronavirus outbreak. Regarding free school meals, we are temporarily extending free school meal eligibility to include children from some groups who have no recourse to public funds. We have been working on providing extra support to keep children at risk of neglect or abuse safe during the COVID-19 outbreak. Since I last wrote to you, we have announced that more than £12 million will be spent on 14 projects across the country to tackle the increased risk some children and young people are facing as they stay at home to reduce the spread of COVID-19. This will include money to pay for individual support for families at risk of domestic abuse, community volunteers to work with families, and continued support for teenagers at risk of exploitation. We have also announced that we will make £1.6 million available for the NSPCC to expand and promote its national helpline for adults. While social workers remain at the forefront of work to protect vulnerable children, including by supporting them to attend school, expanding the NSPCC Helpline will mean many more adults know how and where to raise concerns and seek advice or support about the safety and wellbeing of children.

Ofqual has published a consultation on the exceptional arrangements for awarding

vocational, technical and general qualifications (other than GCSEs, AS and A levels) in summer 2020. We have also made updates to the school admissions appeals process. New regulations give admission authorities the flexibility to manage appeals whilst ensuring families are supported and not disadvantaged by current measures to protect public health.
